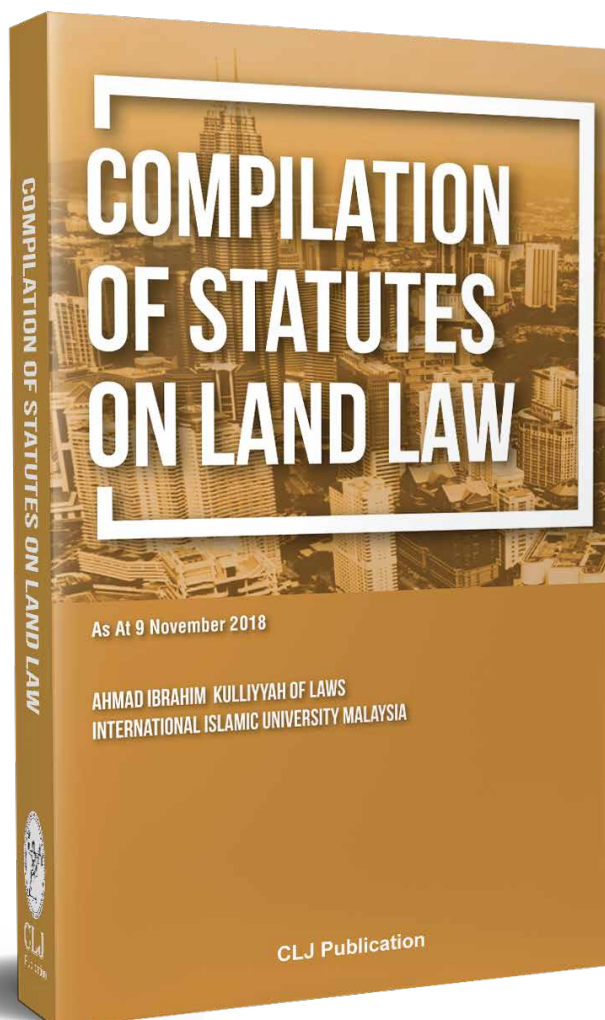

About The Statute

The Compilation of Statutes on Land Law provides the relevant legislation relating to the application of land law in Malaysia. The National Land Code, however, has not provided for matters facilitating the subdivision of building into parcels and the issuance of strata titles, matters related to acquisition of land and the specific law for dealing with Malay Reserved lands. All these aspects are provided in various statutes. The other statutes regulating land dealings, among others, are the Land Acquisition Act 1960, Strata Titles Act 1985, Strata Management Act 2013 and Malay Reservation Enactment of Federated Malay States 1933. As these statutes are equally important, including some relevant statutes on point, this statute book contains important legislation which has been compiled for ease of reference and for the benefit of those intending to refer to the relevant Malaysian land law.
